Facts	What does Cove Street Capital, LLC ("CSC") do with your personal information?
Why?	Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing.
What?	The types of personal information we collect and share depend on the product or service you have with us. Definition	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li>• Cove Street Employee Co, LLC is a holding company for interest(s) in Cove Street Capital, LLC which grants Mirror Interests as part of the Cove Street Capital LLC Incentive Interest Plan.</li> </ul>
Non-affiliates	Companies not related by common ownership control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li>• CSC does not share any information with non-affiliates for their marketing purposes.</li> </ul>
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>• CSC does not carry out any joint marketing.</li> </ul>
